1. **Current accounts Partners:** as of 25.05.2016 for the existing current accounts will be applied taxes and commissions specified in Section I.ACCOUNTS, p. A Current Accounts of the Tariff for legal entities.
2. **Current accounts for Basic Business Package:** as of 25.05.2016 for the existing current accounts will be applied taxes and commissions specified in Section II. PRODUCT PACKAGES /Dinamika Standard of the Tariff for legal entities
3. **Current accounts for Standard Business Package:** as of 25.05.2016 for the existing current accounts will be applied taxes and commissions specified in Section II. PRODUCT PACKAGES /Dinamika Standard of the Tariff for legal entities.
4. **Current accounts for Premium Business Package BGN:** as of 25.05.2016 for the existing current accounts will be applied taxes and commissions specified in Section II. PRODUCT PACKAGES /Dinamika Plus Standard of the Tariff for legal entities.
5. **Current accounts for Premium Business Package EUR:** as of 25.05.2016 for the existing current accounts will be applied taxes and commissions specified in Section II. Product Packages /Dinamika Standard EUR of the Tariff for legal entities.
6. **Current accounts for Private enforcement agents:** as of 25.05.2016 for the existing current accounts will be applied taxes and commissions specified in Section I. ACCOUNTS, p. B Current Accounts for Private Bailiffs and Lawyers of the Tariff for Individuals.
7. **Package of accounts for Notaries:** as of 25.05.2016 for the existing current accounts for Notaries BGN will be applied taxes and commissions specified in Section II Product Packages /Notary of the Tariff for legal entities. For existing current account for Notaries USD/EUR will be applied taxes and commissions specified in Section I. ACCOUNTS, p. A Current Accounts of the Tariff for legal entities. For existing special accounts for Notaries will be applied taxes and commissions specified in section II. Product Packages /Notary Special Account of the Tariff for legal entities.
8. **Package of accounts for insurance brokers:** as of 25.05.2016 for existing current accounts will be applied taxes and commissions specified in Section I.ACCOUNTS, p. A Current Accounts of the Tariff for legal entities.
9. **Package of accounts for Lawyers:** as of 25.05.2016 for existing current accounts for lawyers will be applied taxes end commissions specified in Section II Product Packages /Notary of the Tariff for legal entities. For existing special accounts for lawyers will be applied taxes and commissions specified in Section II. Product Packages /SBB Law Special Account of the Tariff for legal entities.
10. **Safe Boxes:** as of 25.05.2016 for this service will be applied taxes and commissions to Section XIV Safe Boxes of the Tariff for individuals.
